SUPPLEMENTARY COURT ORDERS GRANTED AND REVISED SCHEME TIMETABLE

DRA Global Limited (ACN 622 581 935) (**DRA**) refers to the proposed acquisition of DRA by Apex Capital Partners Limited (**ACP**) to be conducted by way of a scheme of arrangement under Part 5.1 of *the Corporations Act 2001* (Cth) (**Corporations Act**) between DRA and its shareholders (**DRA Shareholders**), pursuant to which ACP will acquire 100% of the fully paid ordinary shares in DRA (**DRA Shares**) as announced on DRA's website on 12 March 2025 (**Scheme**), and the update on the Scheme provided to DRA Shareholders in the website announcements on 18 August 2025 and 21 August 2025.

Orders made at supplementary Court hearing

DRA is pleased to advise that the Supreme Court of Western Australia (**Court**) has made orders at the hearing held on 1 September 2025:

- directing DRA to convene a meeting of DRA Shareholders for the purpose of considering, and to vote
 on, the Scheme on 23 September 2025 (Scheme Meeting); and
- approving the dispatch of a supplementary explanatory statement providing further information on the Scheme to DRA Shareholders (**Supplementary Scheme Booklet**).

On the same date, an office copy of the above orders of the Court was lodged with ASIC.
