CLARIFICATION ON PUEBLO VIEJO NOTICE OF DISPUTE

As first disclosed in the announcement on DRA Global Limited's (**DRA Global**) website on 18 August 2025, DRA Americas Inc (**DRA Americas**), a subsidiary of DRA Global, received a notice of dispute from Pueblo Viejo Dominicana Jersey 2 Limited (**Pueblo Viejo**), dated 11 August 2025 (**Dispute Notice**). The Dispute Notice asserts potential claims against the DRA Global contracting entity and other non-related entities for alleged losses of up to approximately US\$70 million, relating to a conveyor failure that occurred at the Pueblo Viejo Mine in 2023. The Dispute Notice refers, inter alia, to certain engineering design services provided by SENET (a DRA subsidiary) and a design subcontractor, RMCE, as part of the detailed engineering services performed in 2020.

DRA Global, via various group entities, engaged and assisted Pueblo Viejo at the time of the failure with the necessary rectification actions, and is engaging constructively with Pueblo Viejo in accordance with the contractual dispute resolution procedures.

The steel fabricator involved in the conveyor was contracted directly by Pueblo Viejo. The Dispute Notice does not specify how any alleged losses would be allocated amongst DRA Americas, other DRA entities, subconsultants and the steel fabricator. Any such allocation, should a claim be pursued, remains uncertain and would be resolved in accordance with the applicable contractual dispute resolution procedures.

Due to confidentiality obligations, DRA cannot provide further details at this time. DRA is working with its insurers and experts to assess the merits of any potential claim and determine any potential defences and remedies, to which it may be entitled, should a formal claim be pursued.

DRA Global and its subsidiaries reserve all rights, and DRA Global will update its shareholders as appropriate.
